General Release

I hereby assume the sole responsibility for, and agree to indemnify and save the Indemnified Parties harmless from, any and all loss and expenses (including legal fees) by reason of liability imposed by law upon any of the Indemnified Parties for damage because of bodily injuries including death, at any time resulting therefrom, sustained by any person or persons, including myself, or on account of damage to property arising out of or in consequence of my participation in this training class, however such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the Indemnified Parties or any other persons.
